- Space is limited. Sign up today to guarantee your spot!

### Seller’s Guidelines:

- Sellers may not sell new items or items from a business.
- Items for sale must be appropriate for a family audience.
- Sellers must provide their own change and display materials.
- Sellers are responsible for working and watching their space at all times.
- No electricity is available, and generators are not permitted. If using a canopy, you **MUST** have weights, as Moorpark often has windy weather!

## THE FINE PRINT....

**EVENT SITE & AMENITIES:** Single spaces are the size of a standard parking lot space (approximately 18' long x 9' wide). Additional adjacent spaces can be purchased for \$5 each. The event is located at the Moorpark Community Center (799 Moorpark Avenue), in the parking lots. Assignment of spaces will be at the City's sole discretion. Restrooms are located inside the Moorpark Community Center. Parking for seller's vehicles will be specifically assigned by the City.

**CHECK-IN / CHECK-OUT:** Check-in will be on Saturday between 6:00 a.m. and 7:30 a.m. Check-in will close promptly at 7:30 a.m. Spaces must be set up and ready to serve the public by 8:00 a.m. Clean-up and removal of items will begin at 11:00 a.m. For the safety of our patrons, no vehicles will be permitted inside the event area for clean-up prior to 11:00 a.m. You must check out with a City of Moorpark staff member prior to leaving the event. All items must be removed by 1:00 p.m. The City of Moorpark does not accept any liability for missing or damaged items left at the event site.

**EVENT CANCELANATION AND EXCLUSION FROM EVENT:** This event is subject to inclement weather. The City of Moorpark reserves the right to cancel the event under extreme weather conditions and will not accept any responsibility for goods damaged due to inclement weather. Refunds will not be issued; however, credit may be applied towards future event fees. No make-up date will be scheduled. In order to maintain the integrity and family-oriented atmosphere of our event, the City of Moorpark reserves the right to exclude any seller, or to prohibit the display and sale of any item on the day of the event. Sellers displaying unsuitable, political, offensive, or vulgar materials (signs, displays, items, etc.) or any other materials as determined by the City's sole discretion to be inappropriate, will be removed from the event.

**APPLICATIONS AND CONFIRMATION:** Completed and signed application forms and booth fees can be submitted according to the information on the first page of this application. Incomplete or unsigned applications will not be accepted. The deadline for application submission is **May 1, 2026**. Applications are accepted on a first-come, first-served basis until all spaces have filled. All sellers will receive an information packet about one week prior to the event which includes site maps, parking instructions, and any special notices. Please remember that sellers must provide their own change and display materials. All displays, sales items, etc. must fit within the designated space. It is **mandatory** that sellers bring sandbags or weights to stabilize any canopies used, as Moorpark often has windy weather. The City reserves the right to reject any application.

**FEES:** Fees are due in full at time of application. Fees may be paid by check (made payable to: City of Moorpark) or credit card. Cash is accepted only in person at the Arroyo Vista Recreation Center. Payment will be deposited upon acceptance of application. Once deposited, all fees are non-refundable.
