Also, Trunk-or-Treat participants will be thanked and acknowledged in an upcoming edition of the Moorpark Newsletter and Recreation Guide.

There will be a contest to determine the "Best Themed Vehicle". The winner will receive a complimentary half-page ad and the runner-up will receive a complimentary quarter-page ad in an upcoming addition of the City Newsletter and Recreation Guide!
